**Personal data processed.**

The personal data that are processed are:

**Processing purpose and its legal foundation.**

The data is collected and processed for the following purposes:

1. Fulfil contractual obligations deriving from existing relationships. The legal basis for the processing of personal data for the pursuit of this purpose is the execution of a contract pursuant to art. 6 letter b) of the GDPR.
2. Manage administration, accounting, orders, shipments, billing, service provision activities. In this case, the legal basis is the execution of a contract and a legitimate interest pursued by Inalca S.p.A pursuant to art. 6 letter b) and f) of the GDPR.
3. Fulfil the obligations established by law, by a regulation, by community legislation or by an order of the Authority. The legal basis of the processing in this case is the fulfilment of a legal obligation pursuant to art. 6 letter c) of the GDPR.
4. Exercise the rights of the Controller, for example the right to defence in court. The legal basis for the processing of personal data for the purposes set out in this point is the pursuit of a legitimate interest of Inalca S.p.A. ex art. 6 letter f) of the GDPR.

### **Access to data**

Personal data may be disclosed, for the purposes listed above:

- to internal staff expressly appointed by the Data Controller as Designated officer/Designated employee (Article 2-quaterdecies of Legislative Decree 101/2018);
- to External Managers authorised by specific appointment (Article 28 of the GDPR);
- to other companies of the Cremonini Group of which Inalca S.p.A. is part, according to the customer's management policy;
- judicial authorities as well as to all other subjects to whom communication is required by law for the accomplishment of the indicated purposes.

### **Rights of the interested party.**
